Objectives of the Course	The aim of this course is to provide law faculty students with a high level of theoretical knowledge on children in private law and to raise future lawyers with awareness about children, children's rights and the situation of children in private law. Because, although children are also subjects of law like adults, the realization of children's rights and the protection of children against rights violations are of special importance compared to adults. Indeed, in private law practice, it is seen that children do not benefit from the legal mechanisms that enable them to access their rights as much as adults. Thanks to this course, the lawyers of the future will realize the role they will play in children's access to their rights who take this course will know the principle of the best interests of the child throughout their professional lives, will apply this principle and will show all necessary care and effort to observe the implementation of this principle.
Short Course Content	The Child in Private Law course focuses on the concepts of children and children's rights and the reflections of these concepts, especially in the field of private law. The idea of special protection of the child emerged in the 20th century and has developed until today. Within the scope of Child in Private Law course, issues such as the concept of the child, the historical development of children's rights, the child's legal capacity, the child's legal capacity to act, the child's capacity for tortious acts, the protection of the child's personality, the need for special protection of the child while acquiring rights and incurring debt, the child's paternity, the adoption of the child the rights and obligations of the child in his relationship with the family members, the custody of the parents over the child, the appointment of a guardian or trustee to the child, the child's property and management of these properties, and the child's being a party to the service contract will be discussed.
