Objectives of the Course The aim of the course is to enable students to comprehend the basic principles property law and the values on which these principles are based, and to gain the question and interpret human-goods relations based on the property law book of the Civil Code.	
Short Course Content	Within the scope of this course, the concept of real right, the principles of law of property, possession, especially in the context and types of property, gain and loss, termination, protection of property, land registry, title deed registry in particular. The elements of the registry, registration, annotations and declarations, the acquisition of right in kind by relying on the land registry, the responsibility of the State for keeping the land registry, the correction of the land registry, the acquisition of the property right of the persons on the goods, its scope, restrictions, joint ownership, co-ownership, condominium, ownership of the immovable property. responsibility; easements related to goods, usufruct right, right of superficies, right of source; The principles that dominate the immovable pledge, mortgage, the scope of the mortgage, its types, fixed degrees system, movable pledge and pledge of receivables are discussed.
