Objectives of the Course	Health private law has taken on an interdisciplinary character, which has been discussed a lot, especially recently, in terms of the legal institutions it contains. The aim of this course is to ensure that students have a good grasp of the basic concepts of health law, the principles of legal responsibility of health personnel, the obligations of physicians and healthcare professionals, patient rights, informed consent and medical malpractice in medical interventions, within the framework of national and international legislation.
Short Course Content	Within the scope of this course, especially the subjects of "Basic Concepts of Health Law and Institutions and Legislation Knowledge", "Patient and Physician Rights", "Conditions of Legality of Medical Intervention", "Legal Responsibility Arising from Medical Interventions", "Legal Quality of the Relationship Between Patient and Physician", "Malpractice in Malpractice", "Compulsory Liability Insurance of Physicians", "Experiment on Human with Organ and Tissue Transplantation" are discussed.
