In this way, it is aimed to provide understanding of the institutions included in the Turkish Commercial Code, which is an integral part of the Turkish Civil Code.
Short Course Content	Within the scope of commercial law course, after focusing on the provisions of 1 to 10 of Turkish Commercial Code (TCC), the first book of the TCC titled "Commercial Enterprise" (art. 11-123) and the second book titled "Commercial Companies" (art. 124-644) will be evaluated in detail.
